



Frequent Rains results in excessive weed competition







As you prepare to stock up on your annual stock of spices, be prepared for a heated up budget as lower production has pushed prices of spices up this season, in some cases even more than some dry fruits. For instance, the Kashmiri red chillies that add colour and flavour to your dishes cost Rs 850 a kg, higher than almonds which cost about Rs 750 a kg. Similarly, cumin seed (jeera) which is another widely used seed spice also costs Rs 600 a kg in the retail market, surpassing price of raisins which cost about Rs 450 a kg.

So making a flavourful curry would perhaps be nearly as costly as preparing a dryfruit halwa! According to experts, the recent spell

of unseasonal rainfall has damaged a significant amount of crop, resulting in prices going skywards.

India's spice exports need to grow at 19.5% to meet \$10 billion target by FY27

Synopsis

While the Y-o-Y export performance of the industry in FY 2022 declined, India's spice exports (in volumes) in FY 2021 stood at estimated 1.78Bn tonnes, a 37% increase against 1.2Bn tonnes in FY 2020.



To support and achieve \$ 10 billion **exports** by FY 2027, a revised target set by Piyush Goyal, Indian spices should be the torchbearer for **agro products** to boost the prominence of 'Brand India' worldwide. Fetching an annual growth rate of 19.5% is crucial to attaining this goal, says a new report.



Telangana, Andhra Pradesh, Karnataka and Maharashtra are key chilli producing states in India. While demand in domestic and export markets is high, at least 35% crop has failed, hampering the supply. Kashmiri red chillies which are less spicier are in high demand in Gujarat and a majority 40% of the crop in Karnataka — a key cultivator of the crop — has been destroyed."

After Amul, Gujarat's Pushpa chilli could spice up Karnataka politics

"Although the demand for chillies is high, the supply has been badly hit. Generally, at the Byadagi market in Karnataka, the auction of red chillies takes place twice a week. The per week supply - which is 1.5 lakh sacks - has dropped to only 50,000 sacks," Akshay Satija, an Agricultural Produce Market Committee (APMC) trader, told TOI last month.

Last year saw the prices of red chilli surging as output dropped, hit by an invasive pest attack and damage from unseasonal rain in key southern producing states. Lower production boosted prices by as much as 80% in four months to a record high.








Pests attacking during flowering time in chili


